Dear Law School Representative,

We are delighted that you will be joining us at the 2011 BYU Law Fair on Wednesday, October 19, 2011, from 10:00 a.m. to 2:00 p.m. in the Wilkinson Center Ballroom. We hope to make your trip productive and as stress-free as possible. Below are the arrangements we have made for your stay.

Hotel

If you plan on staying in **Salt Lake City**, we have made arrangements with the Marriott University Park Hotel (480 Wakara Way, Salt Lake City, UT 84108). The Hotel has reserved a block of rooms at a rate of \$125.00 + tax per night for Monday, October 17 and Tuesday, October 18. Please make your own reservations with the hotel through the Marriott website by clicking [here](#). If you wish to contact the hotel please call 1.800.228.9290 and indicate that you are with the WAPLA Law Fair.

If you plan on staying in **Provo**, we have made arrangements with the Courtyard Marriott and Springhill Suites (1600 N. Freedom Blvd, Provo, UT 84606). The Hotel has reserved a block of rooms at a rate of \$89.00 + tax per night at the Courtyard and \$95.00 + tax per night at Springhill Suites for Tuesday, October 18. To ensure this rate all reservations must be made before **October 5, 2011**. To reserve one of these room please contact the hotel at 801.373.2222 (Courtyard) or 801.373.0073 (Springhill Suites) and indicate that you are with the WAPLA Law Fair. There is a free shuttle that will take you from the hotel to BYU (approximately a five-minute drive).

Shuttle Transportation to BYU from Salt Lake City

When registering you had the opportunity to sign up for a shuttle to and from BYU at the cost of \$35.00, departing from the Salt Lake City Marriott, University Park Hotel the morning of the fair. If you are not staying at the Marriott University Park Hotel, but you still signed up for the shuttle, make sure you are at the hotel lobby on time the morning of so you do not miss the shuttle.

The shuttle will take representatives to the **Salt Lake City Airport** on the return trip (approximate arrival time at airport of 4:00; luggage can be securely stowed in the under-bus storage compartments for the duration of the law fair). The shuttle will then make a second stop at the Salt Lake City Marriott University Park Hotel for those who are taking later flights out or flights out early the next morning and wish to return to the hotel (approximate arrival time at the hotel of 4:30).

Driving Directions and Parking

If you did not sign up for the shuttle, you will need to arrange for your own transportation to and from BYU. Included with this packet is a map of campus to help you find the Wilkinson Center where the Law Fair is being held and the Visitor Parking Lot directly across from the Wilkinson Center. The drive from Salt Lake City to Provo takes approximately one hour.

Driving Directions from Salt Lake City to Provo:

1. Get on I-15 South
2. On I-15, proceed approximately 45 miles to the University Parkway Exit (exit 269).
3. Exit the University Parkway exit (you will go left over the highway) and go straight on University Parkway for approximately 5 miles.
4. University Parkway will take you onto BYU Campus; it is labeled 1650 North Street on the BYU map.
5. After you pass the BYU Football Stadium on your left, turn RIGHT at the light directly after that (450 East).
6. Turn LEFT at the next light (North Campus Drive)

7. Follow the road as it curves around. You will go under three overpasses. Continue until you see the Wilkinson Student Center on your right. You will turn into VISITOR PARKING on your LEFT. If that lot is full, the parking attendants will direct you to another visitor parking lot that is close by.
