

**2008 BYU LAW FAIR REPRESENTATIVE INFORMATION**  
**WEDNESDAY, OCTOBER 22, 2008**  
**10:00-2:00, WSC Ballroom, BYU Campus**

Dear Law School Representative,

We are delighted that you have decided to come to the 2008 BYU Law Fair on Wednesday, October 22, 2008 from 10:00-2:00 p.m. in the Wilkinson Center Ballroom. We want to make sure your trip is productive and as stress-free as possible. We have made the following arrangements for your stay:

**1. Hotel**

If you wish to stay in **Salt Lake City**, we have made arrangements with the Salt Lake City Marriott, University Park Hotel (480 Wakara Way, Salt Lake City, Utah 84108). A block of rooms has been reserved at a rate of \$129.00 per night for Monday, October 20, and Tuesday, October 21. In order to reserve one of these rooms, please contact the Salt Lake City Marriott, University Park Hotel at (801) 581-1000 or Toll Free 1-800-637-4390 and indicate that you are coming for the WAPLA Law Fair. **Reservations must be made by October 6, 2008** to guarantee the discounted rate.

If you wish to stay in **Provo**, we have made arrangements with the Courtyard Marriott in Provo (1600 North Freedom Boulevard, Provo, Utah 84604). A block of rooms has been reserved at a rate of \$89.00 per night for Tuesday, October 21 and Wednesday, October 22. In order to reserve one of these rooms, please contact the Courtyard Marriott in Provo at (801) 373-2222 and indicate that you are coming for the WAPLA Law Fair. **Reservations must be made by September 26, 2008** to guarantee the discounted rate. There is a free shuttle that will take you from the hotel to BYU (approximately a 5 minute drive).

**2. Shuttle Transportation to BYU**

In the original registration packet, you had the opportunity to sign up for a shuttle to and from BYU for a cost of \$35.00, departing from the Salt Lake City Marriott, University Park Hotel the morning of the fair. If you are not staying at the Salt Lake City Marriott, University Park Hotel, but you still signed up for the shuttle, make sure you are at the hotel lobby on time the morning of so you do not miss the shuttle.

The shuttle will take representatives to the **SALT LAKE CITY AIRPORT** on the return trip (approximate arrival time at airport of 4:00; luggage can be stowed in the under-bus storage compartments for the duration of the law fair). The shuttle will then make a second stop at the Salt Lake City Marriott, University Park Hotel, for those who are taking later flights out or flights out early the next morning and wish to return to the hotel (approximate arrival time of 4:30).

**3. Driving Directions and Parking**

If you did not sign up for the shuttle, you will need to arrange for your own transportation to and from BYU. Included with this letter is a map of campus to help you find the Wilkinson Center where the Law Fair is being held and the Visitor Parking Lot directly across from the Wilkinson Center. The drive from SLC to Provo takes approximately one hour.

**Driving Directions:**

1. Get on I-15 South from the hotel.
2. Once on I-15, proceed approximately 45 miles to the University Parkway Exit.
3. Get off on the University Parkway Exit and go straight on University Parkway for approximately 5 miles.
4. University Parkway will take you onto BYU Campus; it is labeled 1650 North Street on the BYU Map.
5. After you pass the BYU Football Stadium on your left, turn **RIGHT** at the light directly after that.
6. Turn **LEFT** at the next light.

7. Follow the road as it curves around. You will go under three overpasses. Continue until you see the Wilkinson Student Center on your RIGHT. You will turn into VISITOR PARKING on your LEFT. If that Visitor Parking Lot is full, the parking attendants will direct you to another visitor parking lot that is close by.
